- Deter crimes and assure community through high-visibility policing
- Patrol assigned areas and monitor activities to protect people/property
- Investigate crimes and apprehend suspected law violators
- Observe and respond to various situations or emergencies
- Follow rules, guidelines and protocols
- Conduct initial investigations
- Gather evidence and ensure successful prosecutions
- Produce internal reports and provide feedback on case status
- Foster good public relationships and liaise with community groups or individuals
- Coordinate operations with other emergency services
- Attend and provide evidence and testimony in court

Required Knowledge, Skills and Abilities:

- Knowledge of Federal, State and Local Statutes and ordinances.
- Knowledge of law enforcement principles, procedures, practices and equipment.
- Ability to communicate clearly verbally and in writing.
- Ability to work when necessary, in all types of weather.
- Maintains appropriate technical knowledge through continuing self-study.
- Participation in continuing education and training programs as provided by the Department.
- Maintains appropriate knowledge on effects of legislative changes (state and federal) as they relate to the law enforcement.
